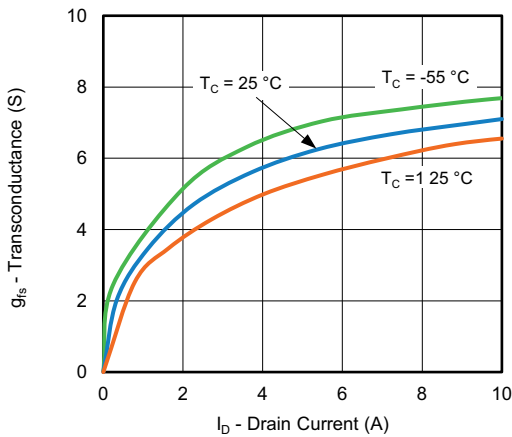

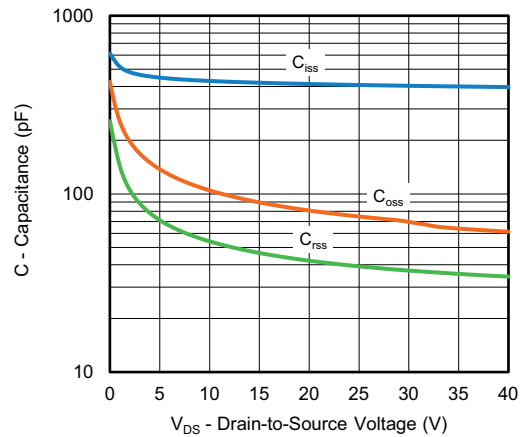

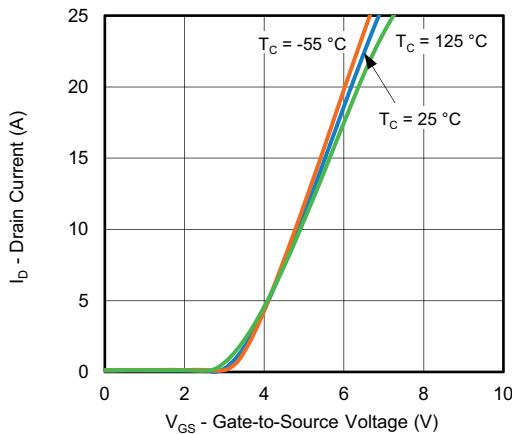
On-Resistance vs. Drain Current



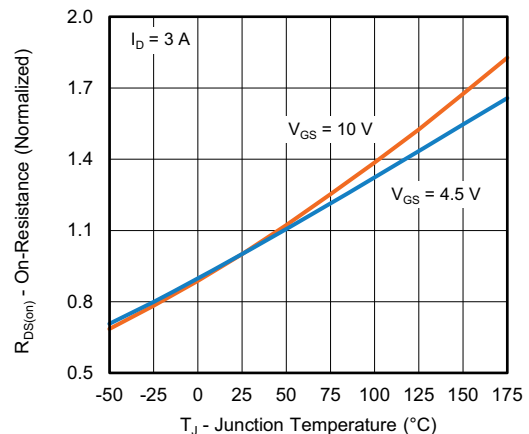
Transconductance



Capacitance

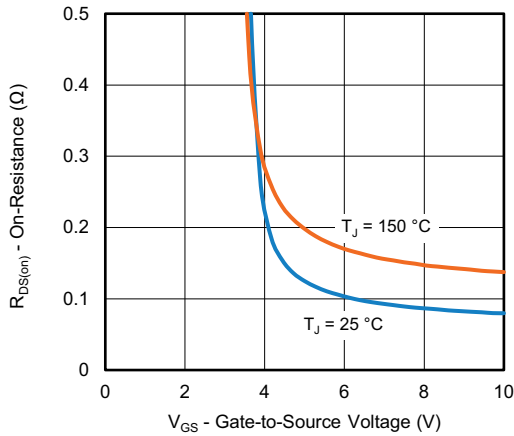

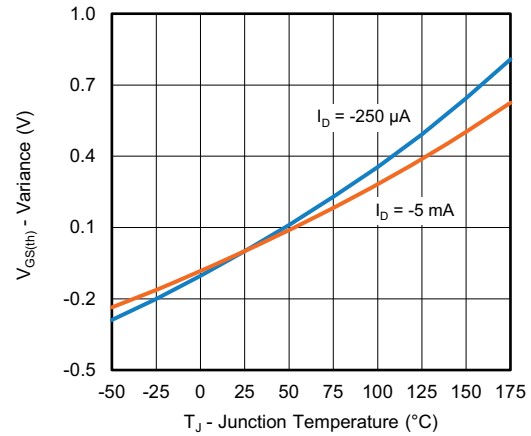


On-Resistance vs. Junction Temperature

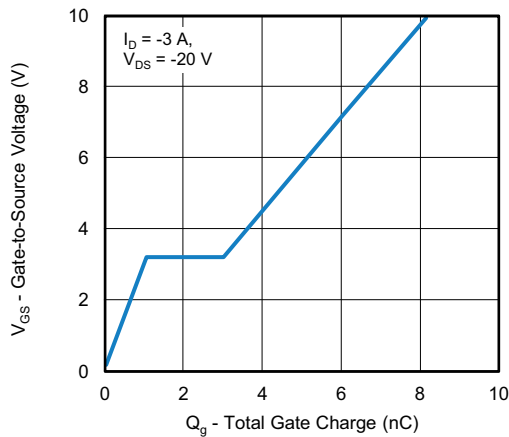

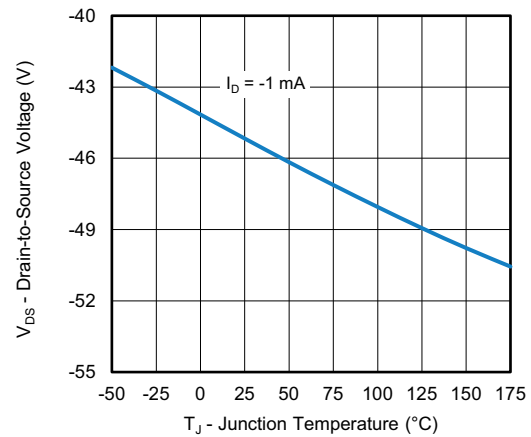
**On-Resistance vs. Gate-Source Voltage**



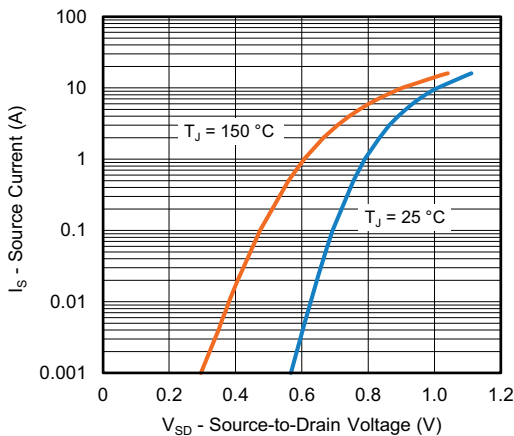
**Threshold Voltage**



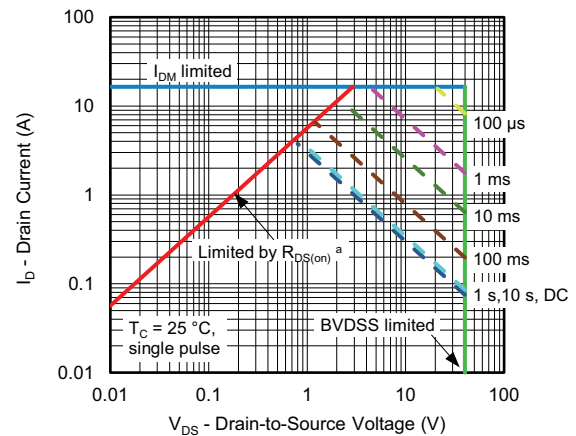
**Gate Charge**



**Drain Source Breakdown vs. Junction Temperature**



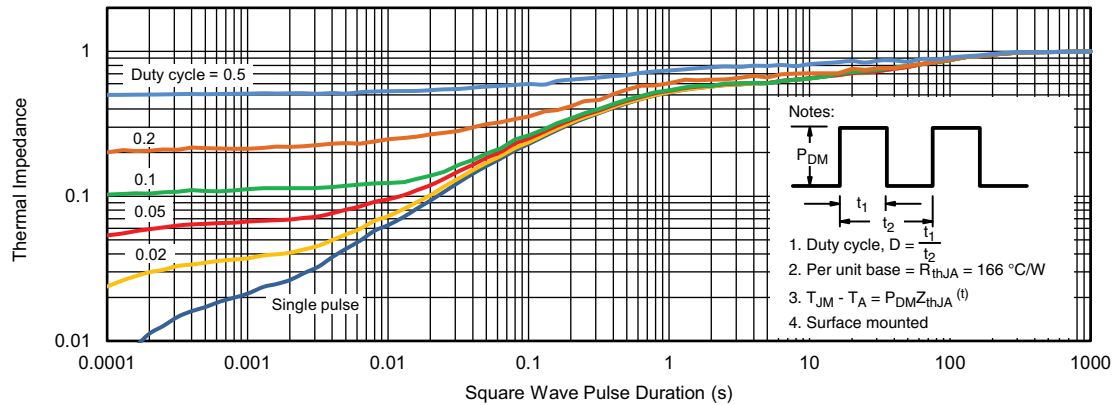
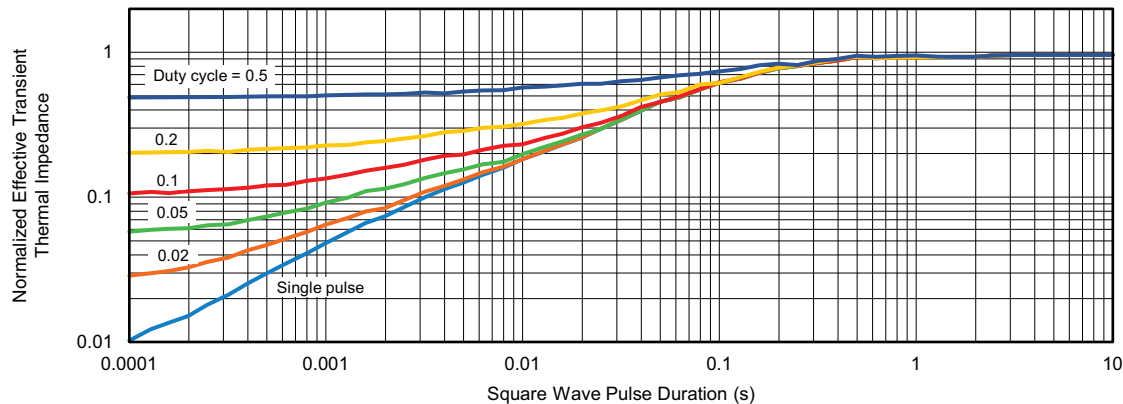
